## **ANTI-DUMPING NOTICE NO. 2017/164**

### **Zinc Coated (Galvanised) Steel**

### **Exported to Australia from the People's Republic of China, the Republic of Korea and Taiwan**

### **Initiation of an exemption inquiry EX0056**

#### *Customs Tariff (Anti-Dumping) Act 1975*

I, Dale Seymour, the Commissioner of the Anti-Dumping Commission, have initiated an exemption inquiry in relation to certain goods the subject of anti-dumping measures applying to zinc coated (galvanised) steel (the goods) exported to Australia from the People's Republic of China (China), the Republic of Korea (Korea) and Taiwan.

The exemption category being sought is under subsections 8(7)(b) and 10(8)(aa) of the *Customs Tariff (Anti-Dumping) Act 1975* (Dumping Duty Act). Under these provisions the Assistant Minister for Industry, Innovation and Science and the Parliamentary Secretary to the Minister for Industry, Innovation and Science (the Parliamentary Secretary)<sup>1</sup> may exempt goods from dumping and countervailing duties where satisfied:

'that a Tariff Concession Order under Part XVA of the *Customs Act 1901* in respect of the goods is in force.'

#### **The Anti-Dumping Measures**

Anti-dumping measures, in the form of a dumping duty notice and a countervailing duty notice,<sup>2</sup> were initially imposed on the goods by public notice on 5 August 2013 by the then Attorney-General following consideration of *International Trade Remedies Branch Report No. 190* (REP 190) and *International Trade Remedies Branch Report No. 193* (REP 193).

Exports of the goods from China, Korea and Taiwan are subject to dumping duty and exports of the goods from China are subject to countervailing duty. A number of exporters are exempt from the duties. Certain goods subject to specified Tariff Concession Orders (TCO) are also exempt from the duties.

### **The Exemption Goods**

The goods the subject of the exemption inquiry are certain galvanised steel ("the exemption goods") meeting the following specific characteristics covered by TCO TC1750287, reported in the Tariff Concessions Gazette<sup>3</sup>:

*SHEETS, flat rolled, non-alloy steel, hot dipped galvanized zinc coated, having ALL of the following:*

- (a) yield strength NOT less than 450 MPa;*
- (b) tensile strength NOT less than 480 MPa;*
- (c) total elongation NOT less than 10%;*
- (d) total coating mass on ALL sides NOT less than 275 g/m<sup>2</sup>;*
- (e) thickness 4.0 mm AND width 1200 mm AND length 2 160 mm.*

*For the purposes of this Order, tolerances allowable for specification (e) are as follows:*

- (i) thickness +/- 0.2 mm;*
- (ii) width +/- 5 mm;*
- (iii) length +/- 10 mm*

The exemption goods are classified to the tariff subheading 7210.49.00 (statistical code 58) of Schedule 3 to the *Customs Tariff Act 1995*. For these goods the general rate of duty is currently five per cent for goods imported from Korea and Taiwan. There is no general rate of duty for goods imported from China.

The exemption inquiry will examine whether the exemption goods satisfy the conditions of the subsections 8(7)(b) or 10(8)(aa) of the Dumping Duty Act.

### **The Current Inquiry**

An application for an exemption under subsections 8(7)(b) and 10(8)(aa) of the Dumping Duty Act has been made to the Parliamentary Secretary by Bluescope Steel (AIS) Pty Ltd. The applicant asserts that there are no substitutable domestic goods to the goods described in TCO TC1750287.

After making inquiries of the Australian industry producing galvanised steel and other interested parties, I will recommend to the Parliamentary Secretary whether the goods should be exempted from the anti-dumping measures.

Interested parties wishing to participate in the inquiry must ensure that submissions are lodged promptly.

Interested parties claiming that information contained in their submission is confidential, or that the publication of the information would adversely affect their business or commercial interests, must:

- (i) provide a summary containing sufficient detail to allow a reasonable understanding of the substance of the information that does not breach that confidentiality or adversely affect those interests; or
- (ii) satisfy me that there is no way such a summary can be given to allow a reasonable understanding of the substance of the information.

Submissions containing confidential information must be clearly marked "For Official Use Only". Interested parties must lodge a non-confidential version or a summary of their submission in accordance with the requirement above (clearly marked "PUBLIC RECORD").

## **Report to the Parliamentary Secretary**

Submissions received in the timeframe stated above will be taken into account in completing the report and recommendation to the Parliamentary Secretary. There is no legislated timeframe for completion of the exemption process.
